

Girl Scout ANN ARBOR NORTH Mom2Mom Sale
SELLER'S AGREEMENT
and TERMS of SPACE RENTAL

This contract is entered into on the day in which registration is completed, by the following parties: Girl Scouts Heart of Michigan Area - Ann Arbor North and the below signed seller. The purpose of this contract is to set forth the rules, regulations and contractual duties of each party to this contract for participation in the Ann Arbor North Mom 2 Mom Sale on Saturday, September 22, 2018. Sale is 8AM-12PM 9/22. Early Bird 8-9AM. Regular hours 9AM-12PM.

The parties agree to the following:

1. Each Seller who wishes to participate in the Mom 2 Mom Sale shall review and sign this contract, prior to the start of the sale in order to complete registration.
2. Upon signing this contract, seller shall pay a space rental fee of \$20 per table. Early Bird Registration till July 14, 2018 is 50% off (\$10 per table). If paying by check, please make your check payable to Ann Arbor North 463. Mail it to GSHOM ANN ARBOR NORTH / Rebecca Knepfler 8456 Huron River Dr. Dexter, MI 48130
3. In exchange for this \$20 space rental fee, seller shall be furnished one (1) 8'x10' space, 1 table, and 2 chairs to be used during the Mom2Mom Sale.
4. Seller is not limited on the number of 8'x10' spaces they may rent.
5. Seller is allowed to bring in their own additional tables, racks, stands from home.
6. Refunds of any money paid by the seller under this contract will only be refundable if the seller cancels this contract and notifies the Area North Sale Coordinator (Rebecca Knepfler) more than fourteen (14) days prior to the above - mentioned sale. No refunds will be given if the seller cancels this contract fourteen (14) days or less from the date of the M2M Sale.
7. Seller is only allowed to sell items that are classified as infant, toddler, child, or maternity related unless approved otherwise.
8. Seller is not allowed to sell consumable items (e.g., beverages, food, formula, medicine, etc.), unless you are a business with prior permission from the M2M Sale organizers
9. Seller shall not display any signs that either advertise or promote a company or service, unless they are registered as a crafter or business or otherwise approved by M2M Sale organizers.
10. Seller is responsible for setting the price of all Sellers' items prior to the sale. Seller is also responsible for marking the price for each item prior to the sale.
11. Seller is only allowed to use their rented space(s). If the Seller elects to bring tables, a hanging rack, or shelving unit to the sale, it must be set up within the 8'x10' space rented to the Seller.
12. Seller is solely responsible for the sale of all items and the collection of all money due.
13. Set up for the above - mentioned M2M Sale will be on the Friday prior to the event. Seller may arrive anytime after 5:00 p.m. to begin setup. Setup is to be completed by 8:00p.m. Doors will be closed promptly at 8:00 p.m.
14. Final setup for the above-mentioned M2M Sale will begin at 7a.m. on the morning of the sale.
15. After Seller has set up their rental space, Seller is allowed to pre-shop the sale Saturday morning from 7:30 a.m. until 8 a.m. If the Seller elects to pre-shop the sale, Seller is solely responsible for the supervision of the Seller's space, table(s), and rack(s).
16. The Girls Scouts Area Ann Arbor North is not responsible for any of Seller's items or monies that are lost, stolen, misplaced, or broken. We strongly encourage the Seller to ensure that somebody is watching the Seller's items and money at all times.
17. If Seller brings children to the sale, Seller is solely responsible for the Seller's own childcare and for supervising the children brought to the sale by Seller. Safety must be a priority. Seller may utilize the Supervised Child Play Area during the sale following the guidelines set up for that area.
18. Prior to setting up assigned space, seller will need to check in at the registration table to receive an information packet.
19. Seller is NOT allowed to pack up his/her space, table, or rack, until the end of the sale unless approved by M2M Sale Organizers.
20. Seller is solely responsible for removing everything from the Seller's space at the end of the sale, all items left after 1pm will be donated to Washtenaw Foster Closet or sold via a resale shop.
21. Direct-sales businesses (Mary Kay, ThirtyOne Gifts etc.) are considered a business. Only one vendor/representative per business will be allowed to have vendor space the day of the sale. (Ex: one Mary Kay space, one ThirtyOne Gifts space.) Vendor spaces are limited.
22. The Girl Scouts Area North reserves the right to cancel this contract and ask any Seller to leave without issuing a refund for the space rental fee for any Seller who breaches the terms of this contract and/or any Seller who is not acting with good and reasonable character.
23. This Contract shall be interpreted under the laws of the State of Michigan.
24. Absolutely NO ANIMALS will be allowed on the Girl Scouts grounds unless they are a service animal.
25. No alcohol, narcotic drugs, or obscene materials will be allowed.
27. Seller agrees to the terms outlined above in the rental contract and will not hold the Girl Scouts Heart of Michigan or Girl Scouts Area North or its members liable for any merchandise brought to the sale that may be lost, stolen, or damaged.
